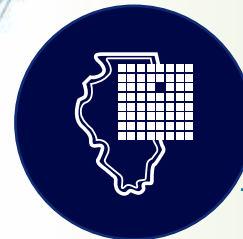
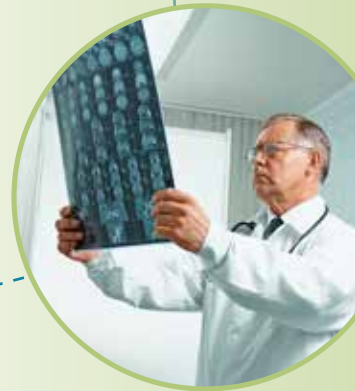

Highlights of 2015 Spring Symposium:

- **Rebecca Parker, MD, FACEP**, Chair of the ACEP Board of Directors, will outline the development of ACEP's 10 recommendations for the Choosing Wisely® campaign and demonstrate their potential cost-saving impact on emergency medicine practice
- **A panel of experts** will examine controversies in head injury and concussion management from differing physician perspectives. Panelists include sports medicine physician Holly Benjamin, MD, FACSM; emergency physician George Chiampas, DO, CAQSM, FACEP; and neurosurgeon Julian Bailes, MD.
- **Michael Wahl, MD, FACEP, FACMT**, Medical Director of the Illinois Poison Center, will assess risk evaluation and mitigation strategies for the safe use of ER/LA opioids for patients in the emergency department. This session is presented in conjunction with CO*RE, the Collaborative for REMS.
- **The Resident Speaker Forum** will provide an opportunity for professional development for novice speakers looking to polish their lecturing skills at a statewide forum, with feedback from an expert panel of judges. One speaker will represent each residency, and a winner will be announced during the Annual Business Meeting.
- **A Statewide Research Showcase** will spotlight the best in Illinois emergency medicine research. Oral presentations will be given during a morning session, and research posters will be on display in the exhibit area.

SESSION OBJECTIVES:

- Describe appropriate patient assessment for treatment with ER/LA opioid analgesics, evaluating risks and potential benefits of ER/LA therapy, as well as possible misuse.
- Apply proper methods to initiate therapy, modify dose, and discontinue use of ER/LA opioid analgesics, including best practices for accurate dosing and conversion techniques, as well as appropriate discontinuation strategies.
- Employ methods to counsel patients and caregivers about the safe use of ER/LA opioid analgesics, including proper storage and disposal.
- Demonstrate accurate knowledge about how to manage ongoing therapy with ER/LA opioid analgesics and properly use evidence-based tools while assessing for adverse effects.
- Review and assess general and product-specific drug information concerning ER/LA opioid analgesics and identify potential adverse effects of ER/LA opioids.

CO*RE is a collaboration formed to address the core competencies necessary to treat patients and effectively and appropriately prescribe ER/LA opioids that meet the requirements of the FDA Blueprint for ER/LA opioids. Find the initiative online at core-rems.org.
