Illinois PMP Program

- Mandatory registration for all controlled substance prescribers 1/1/2018
- » Law requires prescribers to access patient information in the PMP before writing an initial prescription for a Schedule II narcotic, such as an opioid.



Illinois PMP Program

- » Exception for ED Prescribers:
 - > Requirement waived for EDs when 7day or less supply provided by a hospital emergency department when treating an acute, traumatic medical condition
- » Huge backlog in PMP registrations




Threats to Prudent Layperson Laws
