ICEP, IHA Release ED Opioid Guidelines

Every day, an estimated five people in Illinois die from opioid-related overdoses. With overdoses surging 70 percent from 2013-16 and hospital emergency departments seeing a 66 percent increase in opioid overdose visits last year, ICEP partnered with the Illinois Health and Hospital Association (IHA) to develop Opioid Prescribing Guidelines: For Patients in the Emergency Department and Immediate Care Centers. The guidelines were released earlier this spring.

All emergency physicians are encouraged to discuss these guidelines with their staff and colleagues and incorporate them into daily patient care. The guidelines are meant to assist clinicians in treating patients with acute and chronic pain in the emergency department, bolstering the role of clinicians in tackling Illinois' opioid epidemic.

The guidelines were initiated at the request of

IHA's Medical Executive Forum, a group of about 30 physician leaders across the state, in April 2017. ICEP leaders worked closely with leaders from IHA's Institute for Innovations in Care and Quality to create both long and short versions of the guidelines. Both versions of the guidelines are available at ICEP.org to download.

Both versions refer to three common ED scenarios:

- Prescribing for opioid-naïve individuals with acute injuries;
- Exacerbation of chronic pain in patients receiving long-term opioid therapy; and
- Co-prescribing of naloxone and referral to medication-assisted treatment for patients at risk of overdose or with opioid use disorder.

ICEP and IHA leaders aligned the guidelines with those of the Centers for Disease Control

and Prevention, American College of Emergency Physicians, American Academy of Emergency Medicine and The Joint Commission.

In addition, the guidelines align with the State of Illinois Opioid Action Plan regarding:

- Appropriate prescribing in the ED;
- Increased use of the Illinois Prescription Monitoring Program;
- Co-prescribing of naloxone for patients at risk of overdose; and
- Referral to medication-assisted treatment for patients with opioid use disorder.

Before the guidelines were finalized, two external peer reviews involved one-third of emergency department directors from IHA member hospitals. The guidelines were approved and endorsed by the ICEP Board of Directors and IHA's Medical Executive Forum in December 2017.

Highlights of 2018 Spring Symposium

ICEP's 2018 Spring Symposium and Annual Business Meeting boasted one of the largest attendances in recent years, with more than 300 members, non-members, residents, and medical students registered. The Symposium was held May 3 at Northwestern Memorial Hospital in Chicago.

Keynote presenter Salim Rezaie, MD, FACEP, creator and founder of REBEL EM, focused on the concept of "Deep Work" and offered strategies to minimize technology-focused hyper-distraction to be more productive and efficient.

Lightning rounds with expert faculty focused on innovations and hot topics in emergency medicine with targeted, useful take-aways. The topics were well received, including bleeding control for pediatric patients presented by Alisa McQueen, MD, FAAP, FACEP; naloxone and the opioid epidemic presented by Steve Aks, DO, FACMT, FACEP; anti-coagulation reversal presented by Adam Rodos, MD; EMR tips and tricks presented by David Chestek, DO; blunt chest trauma presented by Frederic Starr, MD, FACS; TEG presented by Joseph Palter, MD; and advocacy presented by Yanina Purim-Shem-Tov, MD, MS, FACEP.

The Symposium also included the Statewide Research Showcase. Four abstracts were selected for oral presentation, and 12 posters were on display in the exhibit area. The oral abstracts will be featured in upcoming issues of the EPIC (see page 8 for first article in the series), published with commentary by a member of ICEP's Research Committee. The 2018 eBook of all abstracts from the Symposium is available for download at ICEP.org/spring.

Residents from all of the Illinois residencies competed in the Resident Speaker Forum. Sean Williams, MD, of Presence Resurrection Medical Center, was named the winner for his presentation "Cardiac Arrest: When Not to Call the Code."

ACEP Board of Directors member Christopher Kang, MD, FACEP, will present the keynote presentation on personal finance for EM resident physicians at ICEP's Resident Career Day.

'Total Tox Course' for Emergency Providers Features ICEP Physicians

The possibility of a chemical terrorism event or other hazmat event is a daily reality. Drug overdose has surpassed trauma to become the leading cause of death from injury in the U.S. With these facts in mind, it's clear that emergency physicians need to stay up-to-date in toxicology.

The American College of Medical Toxicology decided to fill this continuing education need and tapped ICEP member Christina Hantsch, MD, FACEP, FAACT, FACMT, Professor of Emergency Medicine and Director of the Division of Toxicology at Loyola University Chicago, to lead the development and organization of the ACMT's Total Tox Course. For nearly 20 years, Dr. Hantsch has been teaching residents and students on the inpatient toxicology clinical service which she established at Loyola. In addition, she is a regular organizer and contributor to local, regional, and national/international continuing education programs.

The course will be held September 5-7, 2018, at the Wyndham Grand Chicago Riverfront. The early registration deadline is July 25.

ACMT's Total Tox Course is a comprehensive



review of the scope of emergency toxicology and will include cutting-edge interventions and management options for poisoned patients. Prominent experts in medical toxicology and emergency medicine will lead the course.

The 3-day course will focus on medical toxicology topics of interest to emergency providers, including toxicological issues of current clinical and public health importance. Attendees will be presented with state-of-the-art updates on the evaluation and initial management of poisoning and exposure to medications, drugs of abuse, chemical terrorism, and environmental toxins.

The course includes all topics in the 2016 Model

of the Clinical Practice of Emergency Medicine Category 17, Toxicologic Disorders, as well as items from other categories with toxicologic overlap.

In addition to Dr. Hantsch's involvement as a conference organizer, she will present a lecture on "Disaster Preparedness #2: Organophosphates and Nerve Agents."

The course will also feature several ICEP physicians presenting lectures on a wide range of topics. Members presenting are:

Statewide Research Showcase Abstract Roundup with ICEP Research Committee

The Statewide Research Showcase Abstract Round-Up is back. Each issue of EPIC will feature one of the abstracts that were selected for oral presentation at the Statewide Research Showcase at the 2018 Spring Symposium, with brief commentary provided by a member of the Research Committee. This month's commentary is provided by Committee Member Wesley Eilbert, MD, FACEP.

Impact of a Novel Audit and Feedback Program on Discharge Opioid Prescribing

Background:

Opioid prescribing in the United States has nearly tripled from 1999-2014, and with it, opioid-related deaths have increased by 200%. Emergency Departments (EDs) may play a pivotal role in the opioid epidemic as they are often the setting for first-time opioid exposures. Many ED providers are not aware of their relative opioid prescribing rates compared to their peers, as demonstrated by wide variability in prescribing practices.

Objective:

We sought to evaluate the impact of a quality improvement initiative intended to provide ED prescribers with individual- and departmental-

wide opioid prescribing feedback as measured by volume of discharge prescriptions before and after the initiative.

Design/Methods:

We conducted a quality improvement initiative at a large urban academic medical center in downtown Chicago, Illinois (annual census > 88,000). We collected discharge opioid prescribing data from all 117 ED providers (48 attending physicians, 60 residents, 9 advanced practice providers) and provided each individual prescriber with their monthly prescribing rate relative to their de-identified peers, excluding providers not discharging at least 20 patients in a month. We compared the aggregate percentage of patients discharged with an opioid prescription before and after the implementation of this initiative using Welch's t-test.

Results:

All 117 ED providers were included in the study population. Baseline data were captured for all groups, with a mean aggregate opioid prescribing rate of 8.3% (range 4.8 – 16.3%; standard deviation 4.3%). In the first four months following implementation of the feedback program, the mean aggregate opioid prescribing rate fell to 6.2% (range 3.3 -13.8%; standard deviation 3.0%) representing a 2.1% absolute and 25% relative decline in discharge opioid prescriptions

($p < 0.0001$).

Conclusion:

Implementation of a novel audit and feedback program of discharge opioid prescribing data was associated with a significant reduction in opioids prescribed from the ED. As this quality improvement initiative may be limited by unmeasured confounders, future studies should explore the impact of similar programs in a randomized and controlled setting.

Impact:

The results of this study suggest that similar audit and feedback interventions might

be useful for curbing opioid prescribing in other EDs.

RESEARCH COMMITTEE COMMENTARY:

As emergency physicians, we are the doctors most adept at treating acutely painful conditions. Unfortunately our efforts to provide short-term pain relief may start some patients down the path of opioid addiction. Just as it is good for us to know how we compare with our colleagues in other clinical parameters (RVUs, patients seen per hour, etc.), seeing our opioid prescribing habits as compared with our partners' provides a useful point of reference. This well-done study shows that a little feedback can go a long way in decreasing the amount of opioids some of us prescribe.

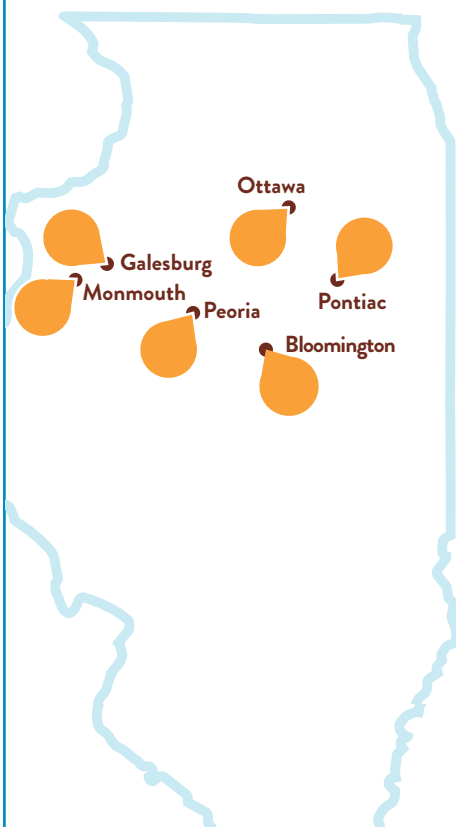
