ECHO is a model used to provide advanced training using videoconference technology. This training is funded by a study that is working to improve treatment of opioid use disorder in Southern Illinois Emergency Departments.

Priority will be given to participants in or near the study region (Major cities: Marion, Benton, West Frankfort, Carbondale, Murphysboro, Harrisburg, Eldorado, Pinckeyville, Massac), but we encourage all Emergency Department providers to register -- if we have additional spots we will open it up to others.



Through this series, ED providers (i.e. physicians, APPs, nurses, social workers, pharmacists, and other ED providers) gain knowledge and skills to improve comfort around important topics related to opioid use disorder (OUD). Case-based learning delivered via Zoom (technology assistance available).

All participants are required to present patient cases during the 8 week series.
