Illinois Sexual Assault and Medical Forensic Services 2-hour Training

The Office of the Illinois Attorney General Sexual Assault Nurse Examiner Program has made available a two-hour online training to hospitals pursuant to Section 10(b) of the Sexual Assault Survivors Emergency Treatment Act (SASETA). The Illinois Sexual Assault and Medical Forensic Services 2-hour Training has been developed "...for emergency department clinical staff to meet the training requirement established in [Section 2(a) of SASETA]. Notwithstanding any other law regarding ongoing licensure requirements, such training shall count toward the continuing medical education and continuing nursing education credits for physicians, physician assistants, advanced practice registered nurses, and registered professional nurses."

At the conclusion of the Illinois Sexual Assault and Medical Forensic Services 2-hour Training, participants should be able to:

- Describe current sexual assault epidemiology
- Review the Neurobiology of Trauma
- Review current Illinois legislation that

mandates the care and services to be provided to Illinois sexual assault survivors, including child sexual assault survivors

- Demonstrate the steps of performing a medical forensic exam, including the evidence collection kit
- Evaluate how to screen for and treat a patient who may have experienced a drug-facilitated sexual assault

The SIU School of Medicine designates this live activity for a maximum of 2.25 *AMA PRA Category 1 Credits*™. Physicians should claim only the credit commensurate with the extent of their participation in the activity.

American Academy of Physician Assistants (AAPA) accepts certificates of participation for educational activities certified for *AMA PRA Category 1 Credit*™ from organizations accredited by ACCME. Physician assistants may receive a maximum of 2.25 AAP Category 1 CME credits for completing this program.

American Academy of Nurse Practitioners Na-

tional Certification Program accepts AMA PRA Category 1 Credit™ from organizations accredited by the ACCME.

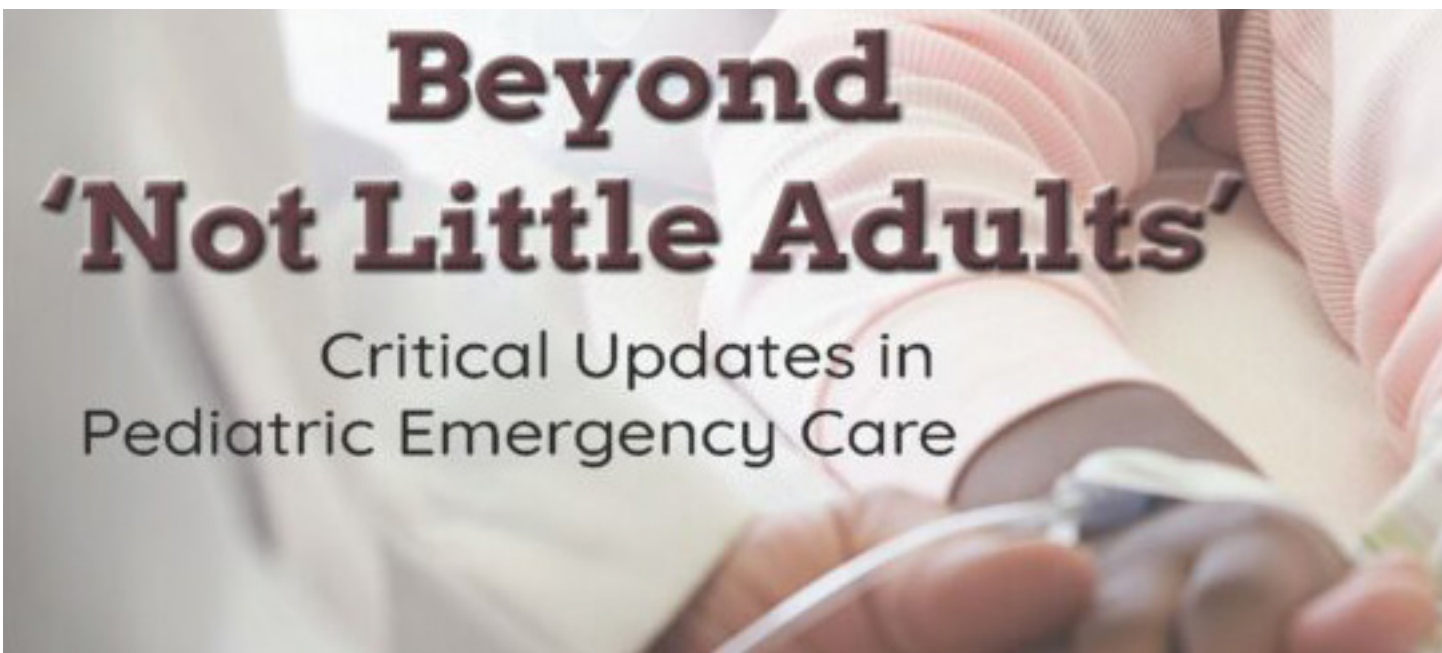
ICEP will be changing our annual Spring Symposium to the Ginny Kennedy-Palys Spring Symposium in her honor.

Governor Pritzker Signs Senate Bill 3023 Today!

Today, June 16, 2022, Governor JB Pritzker signed SB 3023 that allows survivors/victims to opt out of filing private insurance claims for their hospital services. According to the governor's office, this new legislation allows survivors to seek care under the act for 180 days, doubling the time window and extending access to those unable to receive care in the first few months after an incident.

SB3203 guarantees that a victim seeking medical treatment will have access to a trained medical forensic examiner, as well as other medical staff specifically trained to best care for victims of sexual assault.

Illinois will now join the other 42 states that allow victims/survivors to opt out of billing their private insurance for medical forensic exams or who do not bill private insurance at all. This allows those seeking treatment after abuse from partners or family members who share in their insurance policy to maintain confidentiality and avoid additional danger.
